HOW TO SUBMIT YOUR SHOW RESULTS

Checklist

In order to properly track the Chinook Equine Association points and qualifications for the championship show, copies of the following are required to be included in the show results packets that are sent to the CEA Points Keeper following the show. Examples are provided on page 2 and 3 of this document.

Show Master List: This list must include:

Title Line with:

Show Name

Show Date

Show Location

Judge (s)

Body includes:

Entry #

Horse Name (check spelling)

Breed

Registration # (if applicable)

Owner Name (check spelling)

Owner Contact Info

Owner CEA Membership # (if applicable)

Rider Name (check spelling)

Rider Contact Info

Rider CEA Membership # (if applicable)

Rider age if a junior

If adult, AA or Open riding category

Gate Sheets: These must have class titles and the entire class entries included on each sheet.

Judges Cards: A copy from each judge.

Show Premium: For each show result submitted in the Packet. This is your "as ridden" class list, which will help us spot classes that were added after the show class list was submitted for approval.

Contact Person: A person we may contact if there is a question over the show results. Include name, phone number, and email address.

Show Results: Needed for every class.

The Chinook Equine Association point secretary must receive information within two weeks of the show date. Failure to submit results within this time period will result in your organization being placed on probation. See the CEA Rulebook for details.

All final show results must be submitted in a spreadsheet format. It may be sent on CD, DVD or emailed to the address below.
